

**FIRST RIGHT OF REFUSAL** - Each camper is eligible to reserve their RV space from 2016 if payment is made on or before **October 3, 2016.**

<ul style="list-style-type: none"> <li>• Gate Access - Please use the Stock Gate #3 <b>only</b> to access the RV Lot.</li> </ul>
<ul style="list-style-type: none"> <li>• No advance lineup is necessary or allowed as everyone has assigned spaces.</li> </ul>
<ul style="list-style-type: none"> <li>• <b>RV Move-out:</b> RVs may be removed no earlier <b>than 8:00 p.m. on the last day of fair.</b> For safety reasons, please do not move out prior to this time. All RVs need to be removed by 4:00 p.m. on Monday after the fair; contact IVE's Administration Office for a late check-out.</li> </ul>
<ul style="list-style-type: none"> <li>• Fair management reserves the right to make changes to the map based on safety concerns or arising issues. RVs may be relocated to better utilize the limited space in the RV park.</li> </ul>
<ul style="list-style-type: none"> <li>• Please make payment by Monday Oct. 3 in order to secure your spot. After October 3, your spot may be made available to those on a waiting list. Your payment is due by October 3 each year.</li> </ul>
<p>There are a limited number of RV campsites available on the fairgrounds during the run of the annual California Mid-Winter Fair &amp; Fiesta. We have two types of RV spaces available:</p> <p>(1) Full hookup sites are available in the RV Park located north of the wash racks – (30 amps)</p> <p>(2) Dry campsites will be in an area designated by Fair management. The number of Dry spaces may change each year depending on the fair's programming.</p>
<ul style="list-style-type: none"> <li>• Each RV spot receives one parking pass. Vehicles can be parked in the Full Hook Up RV Lot if they can fit in the designated RV space. All fire lanes need to be clear. If your vehicle cannot fit without being in the fire lane, you will be asked to park in a designated parking lot.</li> </ul>

The Fair office will be accepting request forms beginning **September 12, 2016**. All fees must be paid at the time of request - no exceptions and no refunds. Fair management reserves the right to stop accepting requests at any time.

- Reservation must be in the name of the adult responsible for the campsite.
- Dry campsites **do not** have access to water, sewer or electrical hookups.
- Full hookup sites include water, sewer and electrical hookups. **Only 30 amp service provided.** If your RV unit trips the main service line breaker twice, you will be asked to remove the unit from the RV Park. No refunds.
- No electrical or extension cords are allowed in any walkway or aisle. For safety reasons, any cords in aisles will result in lost RV privileges.
- **All RVs must go into the space they previously signed up for. Any RV which is park in someone else's space will be asked to move. No advance line ups please.**
- Livestock Exhibitors Campsite access dates: Mon (2/27), Tue (2/28), and Wed (3/1). **On Monday, 2/27 at 6:00 a.m., only Stock Gate #3 will be open for RVs. No RVs will be allowed on the fairgrounds prior to 6:00 a.m. Any vehicle on the facility prior to 6:00 a.m. on this day will be subject to towing at owner's expense.**
- Full hookup campsites will receive **one** Parking Permit (to be placed in conspicuous location at front of vehicle) and **one** Parking Pass for personal vehicle parking in RV Park. Only one personal vehicle per RV Space allowed as long as it fits within designated space. If it does not, it must be parked in a designated space outside of the RV Park. All other vehicles must park in the overflow area.
- Full hookup RV's must be positioned where they will fit best in their designated space.
- Dry campsites will receive **one** Parking Permit (to be placed in conspicuous location at front of vehicle).
- The majority of our Dry RV sites are back-in sites. Campers are required to park to meet RV layout, safety and fire lane requirements.
- Campsites are for RV's only. Spaces may not be reserved to park additional vehicles.
- If campers are not in place by Thursday evening, the space will be considered forfeited and Fair Management reserves the right to put another trailer in that space. No refunds will be given.
- Parking passes are required for all vehicles entering campsites. Any unattended personal vehicles without parking passes parked in the RV Park will be towed at the owner's expense.
- No additional trailers or hauling rigs will be allowed in campsites.
- Speed limit is 5 MPH on all inside fairground roads. Drivers must obey all traffic rules and operate their vehicles in accordance with applicable Federal, State and local laws.
- All personal equipment and RV sites must be kept clean and neat within your assigned site.
- No alcoholic beverages are allowed outside of RV space. Drugs, weapons, fighting, lewd conduct, reckless driving, speeding, motorized/non-motorized skateboards not permitted.
- No loud radios or music at any time: Quiet hours are between 10:00 p.m. and 7:00 a.m. No loud talking or generators; please be considerate of others. Disorderly conduct will not be tolerated.
- Curfew is 11:00pm. All exhibitors need to be in their RV space at that time.
- No fires allowed: Fully contained barbecue grills and camping stoves are allowed.
- No littering: Littering of the RV Park, RV Site or RV Restrooms will not be tolerated. This includes smoking materials. Extinguish and properly dispose of all smoking materials in proper receptacles. Place garbage and litter in containers provided.
- RV's and all other vehicles must be removed from the grounds by 4 p.m. on Monday, March 13, 2017; otherwise, owner will incur a fee of \$50.00 per day until removed. Contact IVE's Administration Office for a late check-out.
- Any damage to any part of the IV Expo grounds, including fencing, will be charged to the camper and they will lose their camping privileges.

***I hereby acknowledge that I have received and read IVE's Fairtime RV Rules and Regulations and accept responsibility for all occupants in the assigned RV space and that any violation of said policy or inappropriate actions will result in immediate removal from the RV Park and other action deemed appropriate by the Management and/or local law enforcement.***
